VII. Superintendent's Report

The Northbridge Public Schools are full of activity these days!

The first quarter is nearly complete. A true indication that time is flying is that this Thursday; the NMS will be holding its fall band concert at 7PM. We are very excited for the community to hear the new sound system in the auditorium and use the new front entrance doors!

Northbridge High School was recognized at the ribbon cutting for the BV Education Hub in September. We are partnering with Uxbridge High School and the Chamber of Commerce in developing innovative

programming. We are currently partnering to teach advanced manufacturing with student online collaboration.

We have a few recognitions:

Balmer Instructional Coach, Lauren Dolan was selected and invited to participate on a DESE ELA MCAS Alignment Study Panel. She completed an interview process and colleagues at DESE recommended her for the role. The purpose of this panel is to ensure that the MCAS tests are well aligned to the Curriculum Frameworks and display an appropriate range of complexity. This will assist with testing alignment, a requirement of the federal ESSA legislation.

Maura Heney has been recognized by the College Board again this year for her significant contributions as a test reader for the AP Statistics exam. This endeavor requires a high level of subject matter knowledge. She has been chosen to be an exam reader for several years, and we are proud of this achievement and her dedication to such high standards.

Betsy Wermuth and Lisa Gogolinski were the recipients of a BVEF grant of \$1000 to develop a Makerspace at NMS. A die cutter machine will be purchased to address STEM standards. Not only will it serve as a resource hub, but will also be the location for bridge building, robotics, and labs designed to connect content areas.

Grade Six also received #3625 to participate in STEM activities associated with the Mission to Mars at the McAuliffe Center.

Finally, I have been selected to participate in a national focus group sponsored by AASA to articulate the future of education. I am the only representative from MA. It will take place this week in San Francisco.
