- VI. Public Comment (6:35)

Beth Domouchel of 34 Willow St. spoke to provide her farewell to Northbridge Public Schools as she advised she has now removed all of her children out of NPS. She stated that the middle school destroyed them and a teacher made fun of her child in writing and on paper. She feels people have brushed everything under the rug and doesn't want her elementary school student to go through the same thing there. She feels that the only feedback followed through on is for students who are typical or who are in athletics. Special needs children see from the bottom up and they have to fight for the same treatment. She expressed concerns over students being forced to learn critical race theory and gender confusion.

VII. Student Representative Report (6:40)

Student Representative, Sarah Cowen reported that senior graduates attended class events from Monday to the graduation last week including baccalaureate, school walk through, class night, breakfast, and their graduation. Earlier this month, the freshman academy attended a field trip to battleship cove which the students all enjoyed, while the class of 2023 attended a trip to Mystic Aquarium. On June 7th, the class of 2024 will be going to Roger Williams Park Zoo to educate themselves on the impact humans have on habitats and biodiversity. In addition to that, a recent group of students attended a student wellness conference where they learned about healthy and unhealthy relationships and leadership. For an athletics update, she wished luck to all teams playing in the MIAA tournament this week.

VIII. Superintendent's Report (6:45)

Superintendent Amy McKinstry started by welcoming Heather Alden to the School Committee. She thanked Sarah Cowen, the Student Representative for stepping in and doing an amazing job. The district is in high gear and NES is wrapping up their last ST Math student recognition activity where parents were invited to participate. Student's grades K through 2 had a field day yesterday and the grade 5 celebration will take place on Friday. There will also be field trips held throughout the district to make up for lost time. NES has met 100% of their journey goal for ST Math and will be hosting a summer camp for students in grades 2 through 5 for academics and SEL. Superintendent

McKinstry recognized staff members at NMS who stepped up during difficult times, especially the NMS science department. Thursday, NMS is also hosting a fifth grade step-up day and summer school notifications will be going out shortly. Lastly, she advised that the graduating class received 2 million in scholarship money cumulatively.

IX. Introduction (6:50)

A. SEL Coordinator – Joel Khattar

The new SEL Coordinator, Joel Khattar introduces himself and provided information on his background. He has been with NPS for almost 2 months now. He is a father of 2 children with SEL needs and has a background of 12 years in education and 4 years as a program director for a mental health non-profit. His goal is to build an SEL PBIS system at the middle school and identify areas that need attending. He will also be interviewing potential PBIS coaches. He has worked closely with the liaisons for parent newsletters, started SEL files for teachers to grab resources, and developed SEL activities for families at home.

X. Presentation(7:00)

A. Teacher of the Year

Scott Sponseller was awarded teacher of the year. He was the most nominated staff member in the unsung hero awards and administration agreed. He volunteers to help, he helps run the freshman academy, plans field trips, serves as a class advisor, and is an amazing and humble person.

B. Retirees

Retirees of the district were honored. This included Ann Cunningham for 7 years of service, Bill Bishop for 2.5 years, Lisa Lukasek for 15 years, and Karlene Ross for 10 years.

C. Curriculum and Instruction Update

Director of Curriculum, Jill Healy provided an update on curriculum and instruction. In an effort to respond to learning loss due to Covid-19, the focus has been on calibrating and strengthening instruction. Teachers received PD on core reading instruction and a grant for writing was pursued, which the district received. K-5 staff and K-3 teachers will receive the PD on self-regulated strategy development through this grant. In the first year of ST Math grant, K-5 students have learned through puzzles and problem solving, the students love it as it is a fun way to learn. The NMS department chairs are developing proficiency scales as a framework to align curriculum and instruction, identify expectations for students, and make the teaching and learning process transparent. This summer, NMS science teachers will participate in training for new curriculum. Jill also touched on the success of the freshman academy and that they will work to refine the model for continued success. NHS is also working with the Blackstone Valley Ed-Hub to improve their science pathway and Mr. LeMay is now offering a new course on indigenous peoples history which has been the most popular elective class. They are also working on pen pal programs with students from Britain and creating student led research opportunities.
