a. Budget Timeline

Approximately 1/15 for first major review. No need for approval. Parameters for budget, Two views requested: Level services and Level funded.

b. NMS 1905 Section:

Plaster issues: Mr. Zwyien provided an update to the committee. No plaster has fallen in 2 weeks. There are cracks. The drop ceiling has hidden some of the cracks/issues.

Plan is to move classes out of the 1905 section into the basement area. The basement area is currently used for district maintenance storage and repair shop. Plan is to dispose of old storage items that cannot be used. Cost would just be the trailers to dispose but that would be offset by the revenue from the metal recycling. This will free up 4 rooms but the need is for more than that. There are portable classrooms available for use. Music and art classes will move.

Special Education classes will not move to the basement.

Dumpster will be in place by 11/26 and the space ready in January, assuming we receive approval at Town Meeting.
