a. Spring Town Meeting Capital Article

from the undesignated fund balance (free cash) the following sums of money to be expended under the direction of the School Committee: \$106,400 for District-wide technology purchases; \$32,000 for heating system repairs at the Middle School; \$12,000 to install a safety hand railing on the pathway leading up to the High School upper fields; \$40,000 to replace existing stair treads at the High School; \$46,500 to abate asbestos in the Middle School boiler rooms; and \$13,100 to purchase two floor burnishers and two floor buffing machines.
