- VII. Superintendent's Report

Superintendent Amy McKinstry advised that she had the opportunity to spend time in each school last week and had the chance to speak to many students who were happy to be back in school. She commended the way that teachers have overcome the challenges this transition faced them with. Some of these challenges included students not having their audio or video on during class meetings. Amy advised that in order to maximize instruction time, she is asking parents to please assist with this. Amy informed that there is now a COVID-19 data table on the Northbridge Public Schools website that reveals the number of students and staff quarantined and is updated at least weekly. She then went over the current numbers. Amy also spoke about the NHS Best Buddies virtual chapter having their first meeting, and updated everyone on the current status of MCAS for 11th grade students, advising that it will be pushed to later in the spring. Amy advised that NMS principle John Diorio has recruited approximately 40 parent volunteers to assist in day to day activities in the school, delved into the workshop being offered for parents, and went over some exciting events that

happened or will be happening within the schools for students. Amy informed of the Friends of Lasell brick fundraiser and advised that individuals could get more information at friendsoflasell.com. Amy also advised there would be a pick-up of approximately 2,000 masks on Thursday and that she would look into the possibility of offering an SAT for Northbridge students only.

VIII. Presentation: Glen King, Community Preservation Committee

Glenn King reminded the committee of the Community Preservation Act developed in 2017. This provides money for residents of Northbridge to request for use towards historic preservation, open space and recreation, and affordable housing. Brian Paulhus evaluates the requests for funds before it then goes to the town meeting where they can approve or deny the spending of money. This money is contributed to by 10.00 from residents' real estate bill and can be utilized for School Committee projects, by residents, and in other towns, students have utilized these funds for projects as well. There is weight given to requests where others support it and the requests can't overrun the duties of the town. The process of evaluating the requests can take a couple of months.

XII. Discussion

A. Winter Sports Update

NHS Principle Timothy McCormick discussed the status of winter sports. He advised that there was a letter recently sent out to all student athletes and their families informing them of the winter sports

season being postponed to start on January 4. There had been several meetings held between Athletic Directors, Superintendents, and principals to discuss how winter sports can be carried out safely. They have touched upon the possibility of exposure and who is considered a contact, and the ventilation of indoor venues. There had been a vote taken to postpone until after the holidays and revisit given the current pandemic circumstances.

XIII. Information

A. Student grade/progress information – 1st quarter

Steven Falconer advised that this topic should be a discussion item and brought up that the data for both 7th grade students and high school sophomores is concerning and sticks out the most. He brought up how resiliency in these situations as well as social emotional health in middle school is concerning and something that should be addressed. Amy McKinstry informed that she will be looking into whether or not there is a correlation between absenteeism and the heightened failure rates. She does believe there is a relationship between low grades and the students' participation and attendance. This is currently a nationwide issue and it will be addressed at the next leadership team meeting. There is also an idea that some of this data is also reflected as students who also struggled from the spring. Students lost a lot at the end of last year leading to regression. They are going to expand the buddy tutor program to high school students, and look into new after school programming as well as strategies about communication with families regarding student performance.
