#### XIV. Discussion

#### A. District Strategic Plan – Year Three

Superintendent Amy McKinstry advised the committee that they are in the third year of the 3 year district strategic plan and will be focusing on making sure they have wrapped up and completed everything that they set forth to complete within the plan. Come spring, the leadership team will begin to develop the next plan. Amy went over the main 3 objectives included in this year of the plan. These objectives included a safe and healthy learning environment, academics, and a culture of collaboration and community. Amy then went into further depth about the actions that will be taken in order to support and complete these objectives. Amy advised that she expects most of these objectives and goals to be completed by the end of this plan, however there are some that will remain ongoing.

#### B. Hybrid Transition Update

Superintendent Amy McKinstry addressed the transition to hybrid and advised that the school system is on track to open for November 30<sup>th</sup>. At this time, all buildings have received the proper technology and she discussed the current staffing status at each of the schools. Amy believes the schools are in a good position with the staffing in each building. Amy advised that there are many parents volunteering to assist in the schools and that Northbridge Middle School has a large, helpful group of parents willing to volunteer their time. Amy informed the committee that she had sent out a travel survey to all families in order to gain a better understanding of their Thanksgiving travel plans. This was done in an effort to follow-up with families and make sure that their students will be transitioning into the hybrid learning in the safest manner possible. Steve Falconer asked Amy about the status of winter sports as well as the trends of grades from this past term. Amy advised that there was a meeting to discuss winter sports tonight and she does not have the end data for grades yet, however these two topics will be updates at the next meeting. Amy then addressed the issue of absenteeism in students.
