VII. Superintendent's Report

Although the summer is coming to a close, it has not been quiet around the Northbridge Public Schools!

The School Building Committee has net numerous times over the summer to tour facilities, review existing conditions, and review information provided by the Educational Visioning Committee. We are looking forward to our second community forum next Monday at 6PM at NES.

We hosted summer school programs at NES, Middle School, and the High School. We also held our three-week SCIP program at NHS, which had 51 participants. One new component this year included a community service experience, which entailed students assisting in the Community Garden or stocking the new Food Pantry at the High School. We also hosted the Jr. Police Academy again for a second year, presented by Officer DeJordy.

Amy McKinstry and I were asked to participate on a panel with DESE staff regarding "Planning for Success" - successful action planning to address strategic goals.

Popsicle Play dates at NES brought new and old friends out to visit. Thank you to the teachers who popped in from summer vacation to greet our students. Read Around the Town and our Community Reading were well attended. We host the final session of the Community Reading for Hillbilly Elegy next Tuesday at 2PM at the Social Library. Anyone may still join for this session.

A great deal of work has been completed to update our technology and facilities this summer. The tech team shared that they upgraded anti-virus software on over 1000 machines, as well as switching out machines from building to building. We have also increased our internet speed and added more access points with our MassIT grant.

We implemented a Substitute Teacher Orientation program this summer that allowed us to provide our mandatory training for the year, while providing a handbook and answering questions.

Band Camp has started their work for the new year; Link Leaders are back this week for training; Freshmen come for Orientation on Friday; Student packets are being distributed this week; the Balmer Welcome Back picnic is Thursday evening. Our student athletes have started reporting for practice.

We are ready for the new year - and look forward to greeting staff on Monday and families and students on Tuesday to say hello for School Opening hours.
