Kate Tracy of 139 Morgan Road spoke regarding middle school sports and the fundraising that has previously been done to keep these programs running. Due to the pandemic, fundraising couldn't happen, and students already missed out and could not play last year. She asked the committee to consider adding middle school sports back in to the budget.

VIII. Superintendent's Report

Superintendent Amy McKinstry updated the committee on the status of summer programming including the traditional programs and the extended programs. The Covid-19 compensatory camp will be starting for special education students where they will get to participate in many great activities. The Blackstone Valley Ed-Hub Cooperative Enrichment Program starts next week. The first two weeks are grades 8 to 10 and the second two weeks are grades 6 to 7. Amy provided further information on the summer acceleration academies as well. Amy shared a

letter from the ASA \$450,000 grant to extend non-traditional courses. The tiered focus monitoring review was completed and the district did well with only one area of focus to work on. At this time there have been no DESE updates or guidance in relation to masks or protocols. HEPA filters will continue to be used in classrooms. Amy discussed inquiries regarding Lasell Field use and the track. The district will continue to provide breakfast and lunch free to any family on Tuesdays between 9 and 11:00 am at Northbridge High School.

A. New Three-Year District Strategic Plan

Amy thanked all of the individuals who participated in the development and presented the new mission statement and vision statement. Amy discussed the 3 strategic objectives and discussed the process used to develop the plan. She then expanded on the idea of hosting office hours for staff.

B. Elementary SEL Camp Update

Nick Hoffman and Karlene Ross presented an update, advising that the camp during the last week of June was successful and hosted 100 students grades K through 5. They acknowledged the 5 teachers who helped run it and mentioned that kids were engaged, parents were pleased, and it was the first time many of these students saw their friends without masks. Nick provided insight on the competencies addressed as well as the activities that occurred.
