BACKGROUND: This is the annual action item to approve the district to accept School Choice students for the 2017-2018 school year.

STATUS: The district is currently accepting School Choice at every grade except for grade 3 due to enrollment.

FINANCIAL IMPLICATION: By accepting School Choice students, we can generate revenue for the town by accepting students who are interested in attending Northbridge Public Schools and partaking in the strong programs we have to offer.

RECOMMENDATION: The Superintendent recommends that the School Committee move to accept School Choice students for the 2017-2018 school year.

A recommendation for grade closure may follow closer to the start of the 2017-2018 school year.

Regulations at 7 CFR 210.14(e) require school food authorities (SFAs) participating in the National School Lunch Program to ensure sufficient funds are provided to the nonprofit school food service account for meals served to students not eligible for free or reduced price meals. There are two ways to meet this requirement: either through the prices charged for "paid" meals or through other non-Federal sources provided to the nonprofit school food service account.

This memorandum provides guidance on the calculations SFAs must make in order to ensure they are in compliance with these requirements for School Year (SY) 2017-18. In addition, attached is the SY 2017-18 Paid Lunch Equity (PLE) Tool to assist SFAs as they make these required calculations.

SY 2017-18 Paid Lunch Equity Calculations

For SY 2017-18, SFAs which, on a weighted average, charged less than **\$2.86** for paid lunches in SY 2016-17 are required to adjust their weighted average lunch price or add non-Federal funds to the non-profit school food service account. The amount per meal increase will be calculated using 2 percent rate increase plus the Consumer Price Index (2.64 percent), totaling **4.64** percent.

SFAs are reminded that they must use their <u>unrounded</u> adjusted average paid lunch price requirement from SY 2016-17 when calculating the weighted average lunch price increase for SY 2017-18. For example, if the unrounded SY 2016-17 requirement was \$2.28 but the SFA opted to round down to \$2.25, the calculation of the SY 2017-18 requirement is based on the \$2.28 unrounded SY 2016-17 requirement.

A message to parents and community stakeholders:

Massachusetts has statewide learning standards that outline what students are expected to know and be able to do in each subject area and grade level. The standards set high expectations for all students – regardless of the school district they live in.

More than 20 years of education reform

The 1993 Massachusetts Education Reform Act introduced learning standards, helped all districts meet baseline funding levels, introduced new requirements for teachers, and created MCAS to measure students' progress on the standards. From the middle of the pack to #1 in the nation

Since the implementation of education reform, Massachusetts students, who once lagged behind other states, are now leading the nation in academic achievement. Massachusetts students are also competitive on a global scale.

Yet while Massachusetts students perform well overall, some students are not achieving at a level that prepares them for success after high school. The state's education leaders understand that preparing our students for the 21st century requires frequent re-examination of and improvements to our standards and assessments.

Teachers use standards and tests to help guide their instruction

Learning standards are not classroom curriculum, so while the state sets what students need to know and be able to do in each grade level, many decisions are made at the local level. Curriculum, lesson plans, books, materials and other resources are all selected locally, sometimes at the district level, and sometimes, as in the case of specific materials, by individual teachers.

(Although some states have mandated curricula and textbooks, that is not true in Massachusetts.)

3. Instruction


Teachers provide instruction that helps students learn and retain information so that they build on their knowledge each year.

The state, working with Massachusetts educators, establishes learning standards that describe what a student should know and be able to do at each grade level.





Understanding the Commonwealth's strategic plan for education

Massachusetts wants all students to enjoy success after high school. Students will be college and career ready, prepared for civic life, demonstrate skills and abilities necessary to successfully complete credit-bearing college courses, participate in certificate or workplace training programs, enter economically viable career pathways, and engage as active and responsible citizens in our democracy. In pursuit of these student outcomes, we will:



Strengthen standards, curriculum, instruction, and assessments

The Massachusetts Curriculum Frameworks are designed to increase academic aspirations and raise expectations for learning. By setting and measuring high expectations, deepening professional learning for educators, and supporting child-first instruction, ESE aims to support Massachusetts educators in implementing robust instruction that is aligned to our state's strong standards. ESE is developing a statewide next generation assessment aligned to those standards and designed to provide districts with feedback on student progress in attaining the standards.

Promote educator development

ESE aims to ensure that all students have access to highly skilled educators by supporting a cycle of continuous improvement and identifying opportunities to develop and retain highly effective educators. The Commonwealth's approach to educator development involves setting high standards for educators, evaluating educators based on those standards, and providing targeted professional development. ESE is also deeply engaged in strengthening the educator workforce by implementing more rigorous educator preparation program review standards, implementing performance assessments at the pre-service stage for administrators and teachers, and facilitating continuous improvement with educator preparation programs and the districts they serve.

Support social-emotional learning, health, and safety

Research and experience demonstrate that preparing all students for success (in school, the workplace, civic life, and more) includes attending to their social-emotional and health development. Furthermore, academic and social-emotional competencies are mutually reinforcing. Key levers in this work include safe and supportive school climate and culture, and effective family engagement. ESE is committed to building out supports and policies in partnership with practitioners in the field and other state agencies to advance this work in the Commonwealth, both in and out of school. It is our goal to promote systems and strategies that foster safe, positive, healthy and inclusive learning environments and address students' varied needs in order to improve educational outcomes for all students.

Turn around the lowest performing districts and schools

The state's lowest performing schools require additional resources and evidence-based interventions to support their rapid improvement. Our mission is to turn around underperforming schools and districts by supporting sustained improvement, so that all students have access to high-quality, culturally relevant learning opportunities that prepare them for successful futures. We know that if we can support our lowest performing schools in establishing a community of practice through leadership, shared responsibility, and professional collaboration: employing intentional practices for improving instruction; providing student-specific supports and instruction to all students; and providing appropriate social, emotional, and behavioral supports in order to create a safe, orderly, and respectful learning environment for students and teachers, then schools will achieve meaningful improvements in student learning, so that students are prepared for success after high school.

Use technology and data to support teaching and learning

The agency aims to promote effective data use in classrooms by equipping educators with useful reports and providing support on their use. Our initiatives seek to improve data infrastructure and promote a culture of effective data and technology use in districts and schools. The following core beliefs guide our work: technology represents a powerful tool for facilitating student engagement and higher-level learning at scale; technological savvy has become increasingly essential for students as they enter college and the workforce; empowering educators and leadership teams with data and instructional tools will enhance targeted decision-making and improve student outcomes.
