RE: Town: 'Financial Offsets' Proposed New Balmer/NES School Funding. Suggestively help the Taxpayers, and in the passing of the new School.

As you may be 'all' aware being linked in my recent Email conversations with the Town Manager, it appears we may still be at just Home Plate, for any meaningful 'Town Financial Offsets' for the new proposed Balmer/NES School from the Town.

At this time I am respectfully requesting that you consider using 'your authority' under the 'Northbridge Town Charter', where as your elected body sets 'Policy' for the Town. Plus your 'comprehensive authority' under Massachusetts General Law, relative to the 'Powers and Duties', as it pertains to Municipal Government, and 'Policy.' If you may agree with some of my suggestive points in this letter to implement and locate suggestive Town 'Financial Offsets' for the new proposed School?

I am some what 'baffled' in my 'forty year experience' in Municipal/State Government, plus assisting many Municipal Planners. I am some what puzzled that the Town may not be able to find any meaningful 'Financial Offsets' in an almost \$43 Million Dollar annual budget?, plus yearly future predicted revenue growth of #2.5%?, plus the new CPA Revenue?. Plus a main Stabilization account of over \$2 Million Dollars, plus a Health Insurance Stabilization Account of over \$1 Million Dollars, plus a potential future unknown amount in the Towns 'Free Cash' account. Plus make any agreeable very minimal line item Budget Reductions, excluding the School Department, and the DPW?

Do you all honestly feel the Town cannot even find \$100,000 a year, or adding the \$30,000 a year the Town may no longer have to pay for the leased Modular Class Room land at NES? Total \$130,000. This could at least go to the principal on the 30 year term note, if the new School is approved? Plus suggestively reducing the years on the 30 term, or less on what the Town Taxpayers, Renters, may have to pay a year may also be considered?

A Bylaw amendment to the present Solar Proceeds Bylaw, the Town receives from new Solar projects in Town after 2020 approval date? To give the Town flexibility in using the funds for not just maintenance of Town buildings, plus for supplemental funding for new 'Capitol Town' projects? Town Buildings, Fire Station, Schools Etc.

A 'Forensic Audit of all Town Owned Land, and that deemed surplus consider selling, to 'Offset' the new School and maybe a new 'Fire Station'? Other Capitol projects?

Many fellow citizens that I have spoke with advise they are not voting for the new School unless the Town commits to them, what is happening to the NES School? Sell?, new Fire Station location?, or Lease? If sold, or leased, the assets to go towards offsetting the cost of the new School?

Hopefully you may agree to direct the 'Town Manager' to sit down with the 'Office Manager' of our State/Federal elected Representatives to ask, if their may be any additional State/Federal Funding available? Of any Grants?, for the proposed new School, and Fire Station? Relative to the State, if they may put a special line item, in the State FY 2020 Budget for additional funding? New School, Fire Station?

Relative to the new suggestive proposed Senior Tax, Property Exemption, it is my understanding not to many Seniors may qualify do to it's, financial income guidelines, restrictions? But 'something' is better then 'nothing'? One penny over \$20,000 yearly income for one Senior, do not qualify? One penny over \$30,000 income jointly do not qualify? Unknown on savings, 401k accounts, are also counted?

If possible I am asking that you may also request the, 'Town''s' Building Inspector, BPCC, DPW Director, Plumbing Insp, Elect Inspector, also review the proposed plans of the new School? Future Capitol projects? For them to offer their suggestive input on any other possible 'Financial Cost' suggested savings, Construction savings, they may see in the proposed plan?

I am asking the BOS make a public statement at their next BOS Meeting, if any citizen has any cost savings suggestions or idea's, on the new School to forward them to the Town School Building Committee? Plus put it on the Town's Website if applicable, where Residents may see it?

As you all may be aware the Fall Town Meeting Warrant is closed, so if any of these suggestions are considered? Applied? We both know the Town can Amend the new School Article on the Town Meeting floor and add it to the Article the night of the Town Meeting. Plus also on the suggestive Town Ballot in November 2018, if approved at Town Meeting.

In closing I respectfully thank the Board for considering my requests in this letter, and I appreciate the goal we may both share on these Capitol Projects for the Town.
